*Ons vestig u aandag daarop dat dit die eienaar/inwoner se verantwoordelikheid is om toiletgeriewe vir hulle werkers en kontrakteurs te voorsien. Indien daar nie toiletgeriewe beskikbaar nie, moet u 'n chemiese toilet beskikbaar stel met die aanvang, en vir die volle duur van die werk. In die meeste gevalle word dit deur kontrakteurs self voorsien. Chemiese toilette moet binne die erfgrêns geplaas word en nie sigbaar wees vanaf die straat, gemeenskaplike grond en/of die golfbaan nie. Die deure moet weg van die straat en bure wys.*

*Alle werkers word te alle tye beperk tot die grêns van die eiendom waar hulle werk. Hulle mag nie buite die erf in die strate en bosse rondbeweeg nie.*

## NEWSFLASH

### TOILET FACILITIES FOR WORKERS AND TEMPORARY CONTRACTORS

3 July 2023

*Dear Owner/Resident,*

*Complaints have been received that some contractor workers are using the bushes as toilets in the area where they work.*

*You are reminded that it is the responsibility of the owner/resident to ensure that toilet facilities are available for workers and temporary contractors doing work for you. If you do not have any facility available, then chemical toilets should be provided from the start of the project and for the full duration of the work period. In most instances, the toilet facilities are provided by the contractor for his use. Chemical toilets should be placed within the boundaries of your property and in such a way that they are not visible from the street, common area and/or golf course. The doors should be facing away from the street and neighbours.*

*All workers are to remain on the property where they are contracted at all times. They are not allowed to wander around in the streets or bushes.*
