RULES

You are also requested to please assist the Estate Manager when unacceptable actions by visitors and other people are noted. It will be appreciated if people can be advised of the correct actions



The following is listed for attention, please:

- Refuse bags must be placed outside ONLY on a Monday morning – not over weekends. Bags placed outside over night are torn by birds and animals.
- Some workers at homes are using the public areas and Golf Club grounds for toilet purposes. This must be stopped.
- Washing is still
 hanging over
 balconies, fences,
 etc. This is not
 acceptable and
 washing should not

- be seen from public roads and the golf course.
- Our swimming pools are every year a big problem. Vandalism occurs regularly and all residents are requested to PLEASE assist us in managing the pools and the adjacent public areas. If any untoward activities are noted, please call the Reaction Unit on 081 435 0997. A reference can be obtained of the time and date the activity was reported.
- The driving of Golf Carts in the Estate. Please note that the roads in the Estate are classified as public roads and all rules of public roads, applies accordingly. Persons under the age of 18, not in possession of a valid driving licence, are not allowed to drive golf cars on the roads. Within certain rules, made by the Golf Club, they may drive golf carts on the course, during the playing of an official game.
