### **DOGS**

It has been noticed that some owners that are walking their dogs on the estate are not adhering to the rules applicable to pets. They are allowed to run loose, enter the Conservation area and when making a mess, it is not been cleaned up.

Reports of visitors bringing their pets onto the estate have also been received.

Please note that:

- No dog at any time is allowed within the boundary of the Conservation area.
