MOSSEL BAY GOLF ESTATE HOME OWNERS ASSOCIATION (HOA): CHANGE TO CLAUSES 8.5, 8.6, 8.7 and 8.8 OF THE CONDUCT RULES

The Board at its meeting held on 30 September 2021 decided that in order to avoid ambiguity, clauses 8.5, 8.6, 8.7 and 8.8 will with immediate effect be changed as set out in the table hereunder:

| 8.7 | The parking of vehicles, including boats, caravans and trailers, is done at the risk of the owner of the vehicle and no responsibility or liability shall be attached to the HOA for any loss or damage of whatever nature which the owner, or any person claiming through or under him, may suffer as a consequence of his vehicle having been parked on the common property or roads within the estate. | 8.7 | The parking of vehicles, including boats, caravans, motorhomes, trailers and/or any other recreational vehicles used for accommodation purposes, are done at the risk of the owner of the vehicle and no responsibility or liability shall be attached to the HOA for any loss or damage of whatever nature which the owner, or any person claiming through or under him, may suffer as a consequence of his vehicle having been parked on the common property or roads within the estate. |
